CALIFORNIA TRAILBLAZERS is a California general purpose political action committee formed to identify, recruit and advise fiscally conservative leaders and candidates running for elected office. Contributions to the committee permissible under the California Political Reform Act, Cal. Govt. Code 81000 et seq., shall be allocated as follows. CALIFORNIA TRAILBLAZERS will accept the first \$7,300 of any contribution (inflation adjusted for 2017-2018) from a single permissible source in a calendar year into an "all purpose" account to be used for the purpose of making contributions to candidates for elective state office. The remainder of any contribution(s) exceeding that amount from a single permissible source in a calendar year will be allocated to a "restricted use" account for other uses. Contributions are not deductible as charitable contributions for federal income tax purposes. All contributions of \$100 or more will be disclosed on campaign reports filed by the committee. Contributions from individuals must be accompanied by the donor's occupation and employer information. Contributors to California state and local political committees, including CALIFORNIA TRAILBLAZERS, of \$10,000 or more in a calendar year will trigger their own campaign disclosure obligations. Contributors will receive a notice of these obligations if they contribute \$5,000 or more to the committee.
